With a Call for Papers we invited research oriented academics at universities (PhD students, lecturers, professors, etc.) as well as consulting firms, associations, market authorities, etc. to contribute with papers on sustainable issues in banking & finance. Analytical, theoretical and empirical papers are welcome. As an example, topics could be on sustainable investing & finance, ESG related finance, (social) Impact Investing, renewable energy finance, etc.

A selection committee has nominated the best of the submitted proposals and invited the authors to our workshop.

In the coming years, already implemented and under-paced regulatory projects will ensure that sustainability will severely affect business practices in general as well as actors and products of the financial industry. This workshop is designed to stimulate researchers, but also the financial practice, and provide guidance.

The Institute for Finance consists of the departments of Finance and Taxation, and currently comprises three Chairs. Die anwendungsorientierte Vermittlung von Kenntnissen im Bereich der technologischen Neugestaltung bestehender finanzwirtschaftlicher Systeme steht dabei im Vordergrund. Als Absolvent oder Absolventin des Programms verfügen Sie über ein grundlegendes Verständnis für die neuen, noch sichereren und vernetzten Systeme sowie deren Auswirkungen auf neue Geschäftsmodelle und Wertschöpfungsnetzwerke, die über bestehende Unternehmensgrenzen hinausgehen. Executive Master of Laws (LL.M.) in International Taxation

Die ständigen Veränderungen des nationalen und internationalen Steuerrechts stellen eine der zentralen Herausforderungen für die internationale Besteuerung und Steuerplanung von grenzüberschreitend tätigen Unternehmen und Konzernen, aber auch für international über Vermögensstrukturen sowie direkt in Finanzinstrumente, Unternehmensbeteiligungen, Immobilien und Sachwerte investierende Privatpersonen und institutionelle Investoren dar. Diese Herausforderungen erfordern eine steuerliche Spezialausbildung, die sowohl bestimmte nationale und internationale Steuerordnungen und Steuersysteme als auch deren grenzüberschreitendes Zusammenspiel unter Berücksichtigung der verschiedenen Formen der internationalen Steuerkooperation sowie des europäischen Steuerrechts umfasst. Die Studieninhalte des Executive-Masterstudiengangs sind entsprechend konsequent auf konkrete grenzüberschreitende Fragestellungen und Fallgestaltungen ausgerichtet. **Start: September 2020 (next September 2022).**
